Investment Strategy

The Fund

The Fund focuses on corporate bonds and loans with speculative grade credit ratings. The consolidation of high yield bonds and floating rate loans into one category ("high yield credit") effectively doubles the universe for crossover investors, improving the potential to capture underpriced issues and allowing for tactical asset class exposure.

The Approach

The Fund seeks to capture relative value opportunities with fundamental, bottom-up research and tactical asset class exposure. The Fund also seeks to avoid common credit market pitfalls. Our research has observed a trend of high holdings count, high fee, and/or capacity unconstrained high yield funds which we believe detracts from an optimal risk-return profile.

The Features

By utilizing a high conviction, capacity constrained approach to target quality high yield credit opportunities, the Fund has historically provided a complementary and differentiated return profile to peer strategies.

The Fund's advisor has contractually agreed to waive its fees and/or pay for operating expenses of the Fund to ensure that total annual fund operating expenses (excluding any acquired fund fees and expenses, taxes, interest, brokerage fees, certain insurance costs, and extraordinary and other non-routine expenses) do not exceed 0.72% for Institutional Class shares. This agreement is in effect until April 1, 2023. The Fund's advisor is permitted to seek reimbursement from the Fund of fees waived for a period of three years from the date of the waiver or payment to the extent it does not exceed expense limits. Performance would have been lower without fee waivers in effect.

Description of Indices and Terms: The ICE BofA High Yield Constrained Index is a market value-weighted index designed to measure the performance of the US high yield bond market but caps issuer exposure at 2%. The S&P/LSTA BB Ratings Loan Index is a market value-weighted index designed to measure the performance of the US leveraged loan market and is comprised of loans whose rating is BB+, BB or BB-. Standard & Poor's Rating Services is used to determine membership within this sub-index. The BbgBarc Aggregate Bond Index is a market-value weighted index designed to measure the performance of the aggregate investment grade US bond market. An investor cannot directly invest in an index.

Standard deviation is a measure of the dispersion of a set of data from its mean. Sharpe ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk. R-squared measures the relationship between a portfolio and its benchmark. Modified duration measures bond price sensitivity to a change in interest rates, specifically the effect that a 1% interest rate change will have on the price of the bond. **Or 3x the ICE BofA High Yield Constrained Index, not to exceed 25%.
